### **The Breeder Agrees:**

That this puppy is in good health at the time of sale. The buyer shall have 72hrs in which to have the puppy examined by their own veterinarian. If the puppy is found to be ill by a licensed veterinarian and is to be returned due to illness, a letter from the veterinarian is required, and an examination by a Boxer Blvd, LLC veterinarian may be necessary. This includes death or illness from any health condition deemed to be present prior to the leaving the seller's premises (Boxer Blvd, LLC). Buyer shall assume all expenses associated with returning the puppy to the seller. The seller will, at the seller's discretion, refund the purchase price, return the dog to the buyer in healthy condition, OR exchange the puppy for another puppy of equal value. At no time and under no circumstances will the Breeder be responsible for any veterinary expenses incurred by the buyer without the puppy first being examined by a Boxer Blvd, LLC approved veterinarian, and at the discretion of Boxer Blvd, LLC. In such an instance, the bills covered by Boxer Blvd, LLC shall not exceed the original value of the puppy.



**This animal is warranted against FATAL GENETIC Defects for 1 year from the date of purchase.** Should this puppy be determined to be suffering from a fatal defect deemed to be hereditary (within 1 year from the date of purchase), Boxer Blvd, LLC will replace the puppy with one of the same value when one is available after notification and written verification has been furnished to the Breed by two independent veterinarians, and potentially, with a Boxer Blvd, LLC approved veterinarians. We cannot guarantee that your puppy will never develop any health problems, just as a pediatrician cannot guarantee that a child will never develop any health problems in the future. Our parents are free of diseases, disorders, and health problems, which means our puppies are less likely to develop problems

Breeder does NOT GUARANTEE against COCCIDIA or GIARDIA (typically dormant single celled parasites common in puppies) or for final adult weight, color, breeding ability, show potential or against overbites, under bites, patella issues, hernias, trachea issues or for undescended testicles. Seller agrees to notify buyer if they or the vet discover any of the above problems prior to sale.

The Breeder states that the puppy has received the following vaccinations –1 (Parvo Only vaccine at 5-6 weeks old) and a 5-way Vaccine for **Distemper, Parainfluenza, Adenovirus Type 2, Canine Hepatitis and Parvovirus** (at 7-9 weeks old). Your health record will inform you of when a booster is due, your puppy will need 2-3 more puppy vaccines and rabies at 16 weeks old and then yearly boosters. We worm puppies at 4 and 6 weeks old and again at 8-10 weeks of age.

**The Buyer Agrees:**

That this puppy will be given adequate and proper shelter and housed securely indoors. This dog shall not be neglected, allowed to roam free, or be mistreated in any manner. The puppy shall receive proper veterinary care throughout its life, receiving annual inoculations and placed on a heartworm preventative. The puppy shall receive proper nutrition and care shall be taken to maintain its proper weight. Buyer agrees to give the dog proper training and socialization. Buyer agrees to never sell or surrender this dog into a dog fighting institution, testing center or shelter.

Buyer has purchased full registration rights (where applicable) and if they choose to breed the puppy they agree to do so ethically and responsibly keeping in mind the health and safety of the dog and the resulting offspring. With full registration, puppy is eligible for AKC sanctioned events including the conformation ring and if bred with another AKC registered dog of the same breed, offspring may eligible for registration through the AKC. Buyer agrees to notify seller of any and all titles earned by this puppy.

No guarantees or warranties, expressed or implied, are given by Boxer Blvd, LLC, the Breeder, except those stated herein. Breeder warrants and agrees that they are the lawful owner of this puppy and are alone responsible for entering into this contract with the Buyer.
